- (1) Unfitted area rate includes area and 1 kw supply each 16 sq.m. The registration fee and any other item required will be charged. We remind exhibitors booking an unfitted area that they must take care of the distribution of the exhibition spaces (partition walls with other stands, height 3 meters, unless otherwise indicated), and provide all the documentation relating to the layout, that is: 1. Design of stand set-up; 2. Declaration of correct assembly of the Stand; 3. Declaration regarding the fireproof quality of the materials employed (with the relative certificates of the same) 4. Declaration of conformity of the electrical system in relation to the power less than or equal to 6kW or more than 6kW. The eventual company that prepares the area in the name and on behalf of the Exhibitor must also provide: A) Chamber of Commerce registration; B) DURC tax and wage compliance certificate.; C) Self-declaration of technical and professional requirements; D) Declaration in lieu of certification (self-certification of absence of criminal convictions, absence of provisions registered in the criminal record, absence of liquidation / arrangement with creditors procedures).
- (2) The pre-fitted area rate includes stand structure, painted honeycomb wood partitions, electrical system, headlights, electrical socket, graphics with company name, in addition to what is included in the bare area. Only in the Milan edition the pre-fitted area rate DOES NOT include carpet.
- (3) Registration fee (mandatory for each participant and for each edition) including: insurance, exhibitor badges based on square meters, inclusion in the paper and online catalogues, 1 parking card where possible, Wi-Fi connection where possible.
- (4) Further details and costs of participation are indicated in the General Rules and Regulations of Exhibition.
- (5) Surcharge for Corner Booth: supplementary rate for areas looking on to areas with two or more open sides. It is calculated on total area cost (unfitted area + fitted area, if requested).
